Later proceed to Chennai enroute to Visit Tiruttani (65Kms /1Hr) Sri Subramanya Swamy Temple.Tiruttani is one among the six abodes of Lord Muruga. The Temple is situated on hillock and has 365 steps. An important Thirtha called Kumara Thirtha is under this hill this place is called as "SARAVANA POIGAI" and also called as "AARUPADI" later proceed to Chennai (85 Kms/ 2Hrs) Drop at Railway station / Airport.
